

VILLAGE OF RIPLEY, OHIO

ORDINANCE NO. 1086

AN ORDINANCE TO ADJUST RATES AND CHARGES FOR TRASH AND WASTE COLLECTION IN THE VILLAGE OF RIPLEY, BROWN COUNTY, OHIO

WHEREAS, by the Village of Ripley provides trash and waste collection and disposal services for the benefit of its residents; and

WHEREAS, the costs associated with such trash and waste collection and disposal service have increased; and

WHEREAS, the Council of the Village of Ripley believes that is necessary to adjust the rates and charges for such trash and waste collection with the Village of Ripley,

NOW THEREFORE, BE IT ORDAINED by the Council of the Village of Georgetown, Brown County, Ohio, a majority or more of all members thereof concurring as follows, that:

SECTION 1. From and after the effective date of this Ordinance, the rates and charges to be billed customers located within the Village of Ripley for trash, waste and garbage collection and disposal services provided by the Village of Ripley shall be as follows:

Regular Residential	\$10.00 per month
<u>Businesses</u>	<u>Flat Rates, dumpster or can</u>
Taverns	\$50.00 per month
Restaurants	\$40.00 per month
Deli with seating	\$40.00 per month
Deli without seating	\$30.00 per month
Barbershops & Beauty Salons	\$12.00 per month
Hardware Stores	\$28.00 per month
Banks	\$22.00 per month
Offices	\$12.00 per month
Antique Stores	\$12.00 per month
Florists	\$15.00 per month
Service Stations	\$50.00 per month

SECTION 2. Residential customers within the Village of Ripley who are age 60 or over or who are disabled shall be entitled to a \$1.00 discount from the monthly rate set forth in Section 1 of this Ordinance, provided the utility bill for such residence is the name of such person aged 60 or over or disabled.


SECTION 3. Residential customers of the Village of Ripley who are located outside of the corporation limits of the Village of Ripley shall pay the sum of \$12.50 per month for such trash, waste and garbage collection and disposal services.

SECTION 4. Business customers of the Village of Ripley who are located outside of the corporation limits of the Village of Ripley shall pay a surcharge of twenty percent (20%) for such trash, waste and garbage collection and disposal services.

SECTION 5. In the event a business customer of the Village of Ripley trash, waste and garbage collection and disposal service were to be engaged in a type of business not listed in Section 1 of this Ordinance, the rates and charges for such business customer shall be set by the Village Administrator based on the rates and charges set forth for the type of business most closely resembling such business as set forth in Section 1 of this Ordinance.

SECTION 6. This Ordinance shall be in full force and effect from and after the earliest date allowed by law, to wit, thirty (30) days after its adoption.
